

Jeff Hornstein, Executive Director of the Economy League, has served as Director of Financial and Policy Analysis for the Philadelphia City Controller where he advised the Controller and worked on critical issues relating to Philadelphia's fiscal health. Under Jeff's leadership, the Policy Unit produced numerous data-driven policy analyses on topics including the City's property tax system, tax delinquency and receivables issues, tax incentive programs, charter school finances, the efficacy of the City's tourism and convention promotion entities, and the state of retirement security in Philadelphia. In collaboration with the City's Commerce Department, he began coordination of a citywide initiative to increase local spending by Philadelphia's major eds-and-meds anchor institutions, and will continue to coordinate this Anchor Procurement initiative as Executive Director of the Economy League.

In his civic life, Jeff serves on the boards of Queen Village Neighbors Association, a civic association in Philadelphia, as well as the Philadelphia Crosstown Coalition, a citywide organization representing 25 civic associations. He helped convene the Friends Of Neighborhood Education, a citywide initiative to build community support for neighborhood public schools. He has also participated in several of our Leadership Exchanges and ran for City Council in 2011. After leaving academia in 2001 with a PhD in business history and publication of a well-regarded book on the real estate industry "A Nation of Realtors," Jeff spent a decade in the labor movement. He helped low-wage workers in the service and education sectors build workplace and political power. Born in Brooklyn, a product of public schools in Matawan, NJ, with degrees from MIT, Penn, and the University of Maryland, he has called Philadelphia home since 2001.

Donna Bullock, State Rep. D-Phila., is a member of the Pennsylvania House of Representatives representing the 195th Legislative District in North and West Philadelphia. She won the seat in a special election held Aug. 11, 2015. A lawyer and Temple alumna (2004), she previously served as special assistant to Philadelphia City Council President Darrell L. Clarke and as the City Council research fellowship director. She joined Clarke's office in January 2011 as his community and economic development coordinator. Before her work for the city, Bullock worked at a private law firm and for Philadelphia Community Legal Services, where she formed and advised nonprofit organizations, small businesses and community groups.

Aubrey Montgomery is the Principal at Rittenhouse Political Partners, a Philadelphia-based fundraising firm, which she founded in 2013 after more than a decade spent raising millions of dollars in more than a dozen states. Some of Rittenhouse Political Partners' most recent successes include: raising millions to support Philadelphia's bid to host the 2016 Democratic National Convention; launching Represent PAC, a member of the national Electing Women Alliance, which has already helped bundle more than \$100,000 for U.S. Senate Candidates in the 2016 cycle; and raising more than \$18 million for clients running for municipal, state and federal office. Immediately prior to founding Rittenhouse Political Partners, Aubrey, served as the Finance Director for Allyson Schwartz's campaign for Pennsylvania Governor and in the 2012 election cycle, served as the Finance Director for the Pennsylvania Democratic Party, overseeing a nearly \$20 million budget.

Larry Platt is Co-founder and Co-executive director of the Philadelphia Citizen, a non-profit, non-partisan media organization has a dual mission: To provide deeply reported journalism that emphasizes solutions that can move our region forward, and to actively reignite citizenship in and around Philadelphia. A Philadelphia media fixture since the early '90s, Larry Platt is the former editor of the Philadelphia Daily News and Philadelphia magazine, and the co-author of the bestselling Every Day I Fight, the cancer memoir of ESPN's Stuart Scott. He has written for New York, GQ, the New York Times Magazine, and Men's Journal. "I've run two major media institutions in our town and have yet to consistently produce the kind of journalism the city and Democracy truly needs," Platt says.

Giancarlo Stefanoni is a 2012 graduate of Drexel University. He is currently serving as Finance Director for Pennsylvania Governor Tom Wolf's campaign for re-election. In his role, Giancarlo is responsible for leading the fundraising effort for one of the most competitive races in the country in 2018 and a senior member of Governor Wolf's team. Prior to his role with Governor Wolf, Giancarlo spent two years as the Pennsylvania Finance Director for Hillary Clinton's campaign for President and also served on Tom Wolf's successful campaign for Governor in 2014.

Eugene A. DePasquale began his second term as Pennsylvania's 51st Auditor General on January 17, 2017. During his first term, Auditor General DePasquale delivered on his promise to be a tough, fair and independent fiscal watchdog for Pennsylvania taxpayers. So far, his audits have identified nearly \$600 million in misspent or potentially recoverable state money including urging the state pension plans to cut another \$100 million in Wall Street investment fees.
